INSTRUCTIONS FOR FILING:

TAX AMOUNT: Tax rate is 1.5% of total gross receipts. **DUE DATE:** The completed return and payment shall be due and payable on the **twentieth day of the month following the preceding calendar month during with the gross payments were received.** **PENALTY:** **Late charges are calculated at the rate of 2 percent (2%) per month.** **DISCOUNTS:** On-Time Discount and an Online Payment Discount are calculated at the rate of 2.5 percent (2.5%)
